ORDER:

In the Government Order first read above, guidelines have been issued for the vertical separation of the Department into Public Works Department and Water Resources Department. In paragraph 9(C) of the Government Order first read above it has been ordered that all further promotions / appointments from the year 2021-2022 has to be made by the respective Engineer-in-Chief of Public Works Department and Water Resources Department by formulating separate seniority lists as per the extant statutory rules.

2. In the Government Order second read above, orders were issued approving the estimate of vacancies for the post of Superintending Engineer (Civil) in Public Works Department for the year 2022-2023 for '14' (Fourteen) Numbers.

3. In the letter third read above, the Engineer-in-Chief and Chief Engineer (General), Public Works Department, has sent proposal requesting orders of the Government for approval of temporary list of Executive Engineers (Civil) as Superintending Engineer (Civil) in Public Works Department for the year 2022-2023.

In exercise of the powers conferred under Section 58 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016, the Governor of Tamil Nadu hereby relaxes Explanation III under section 7(1) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 relating to preparation of regular panel, in favour of certain Executive Engineers (Civil), so as to include their names in the temporary list of Executive Engineers (Civil) fit for promotion as Superintending Engineers (Civil), during the year 2022-2023 in Public Works Department.
