ORDER:

The following upgradation of Superintending Engineers as Special Chief Engineers and promotion of Superintending Engineer as Chief Engineer on temporary basis, under Section 47(1) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016, are ordered with effect from 31.3.2023 Afternoon:-

- (iii) Thiru. A. Muthaiya, Superintending Engineer, Palar Basin Circle, Water Resources Department, Chennai is promoted and posted as Chief Engineer, Water Resources Department, Chennai Region vice Thiru. G. Muralidharan, Chief Engineer, transferred.

2. The temporary promotion / upgradation ordered in paragraph 1 above, shall be subject to the following conditions:-

- i. Persons temporarily promoted / upgraded shall be replaced as soon as possible by the member of the service, who is entitled to promotion under the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.
- ii. Persons temporarily promoted/ upgraded shall not be entitled by reason only of such promotion / upgradation to any preferential claim to future promotion to such higher category.
- iii. Their service in the post of Chief Engineer / Special Chief Engineers shall be liable to be terminated by the appointing authority at any time without notice and without any reason being assigned, under Section 47(5) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

Muralidharan, Chief Engineer, Water Resources Department, Chennai Region is transferred and posted as Engineer-in-Chief & Chief Engineer (General), Water Resources Department, Chennai vice Thiru. K. Ramamoorthy, retiring from Service on attaining the age of superannuation on 31.03.2023 A.N.
