1. G.O.(D) No. 347, Public Works (A1) Department, dated 18.09.2017.
2. From the Engineer in Chief (Buildings), Chief Engineer (Buildings), Chennai Region and Chief Engineer (General), Public Works Department, Chennai Letter No. CI(1)/2600/2017-3, dated 26.9.2017.

ORDER:

In the Government Order first read above, the Government approved estimate of vacancies for the post of Chief Engineer in Public Works Department for the year 2017-2018 as '6' (Six).

2. In G.O.(Ms.) No. 440, Personnel and Administrative Reforms Department, dated 26.10.1990, it was ordered that for promotion as Head of Department, an officer should have not less than one year minimum period of service before retirement. For those who do not have such a minimum period of left over service but are otherwise found to be fully qualified, fit for promotion as Head of Department and deserving recognition on the crucial date of preparation of panel shall be compensated by appointing them as Officer on Special Duty with a specific assignment and with the same scale of pay as that of the Head of Department. In G.O.(Ms.) No. 631, Public Works Department, dated 23.10.1997, the nomenclature of the post of Officer on Special Duty was changed as Special Chief Engineer subject to certain conditions.

3. In the letter second read above, the Engineer in Chief (Buildings), Chief Engineer (Buildings), Chennai Region and Chief Engineer (General), Public Works Department, Chennai has sent the list of Superintending Engineers eligible for consideration for the temporary list of Superintending Engineers fit for promotion as Chief Engineers for the year 2017-2018.

4. Accordingly, the Government approve the temporary list of the following Superintending Engineers (Civil) in Category 2 in Branch-I (Public Works) of the Tamil Nadu Engineering Service fit for promotion as Chief Engineers in Category 1 of the said Branch of the said Service during the year 2017-2018 in the order of seniority indicated below:-

5. The name of Superintending Engineers, those who have less than one year of left over service, are examined and they are eligible for appointment as Special Chief Engineers as and when their juniors are promoted as Chief Engineers.

6. Even though the names are indicated as appointment for Chief Engineers, those Superintending Engineers who have less than one year left over service as on promotion will be appointed as Special Chief Engineers.

7. The Engineer in Chief (Buildings), Chief Engineer (Buildings), Chennai Region and Chief Engineer (General), Public Works Department, Chennai is requested to communicate a copy of this order to all concerned, as required under Section 7(1) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016. He shall also instruct the Superintending Engineers (Civil), whose names have not been included in the temporary list for the post of Chief Engineer for the year 2017-2018, to prefer an appeal in the matter to the Government through proper channel within two months from the date of receipt of this order.
