# **Assistant Executive Engineer**

The Assistant Executive Engineer should check 50% of all recorded measurements, 75% of hidden items of high unit value and his check measurements should cover 75% of value of the work.

# **Executive Engineer**

In addition to check-measurement by the Assistant Executive Engineers, it is an important duty of Executive Engineers that, the Executive Engineer should during their inspections frequently check measure works which are in progress and they should test check at least 30% of the value of each work costing more than Rs. One Lakh and should maintain a register of such check measurements/test check. The number of check-measurements / test check by Executive Engineer should be at least 24 per annum.

### With regard to Check Measurements by Superintending Engineer,

In G.O.Ms.No.75, PWD, dated 20.01.1976 / G.O.Ms.No.2681, PWD, dated 11.11.1986 / Chief Engineer (General), letter No. CTO / A / 158932 / 89, dated 27.02.1989 stipulates that -

### Superintending Engineer

Superintending Engineers should make it a special point to see that these rules are duly observed, besides inspecting in detail all works above a value of Rs. 10.00 lakhs and certify that they conform to approved designs and estimates and also free from noticeable defect.

Works costing more than Rs. 10.00 Lakhs in agreement value should be super checked by the Superintending Engineer and a certificate issued by the Superintending Engineer as stipulated in Para 297 of TNPW 'A' Code.

The Administrative Reforms Commission in its report on the Public Works Department, Administration, has remarked that the powers delegated to the various officers of the Public Works Department which are in terms of money value have over a period of years undergone changes. In view of the increase in the cost of materials, labour, etc., these powers have to be revised for the purpose of making a fuller utilisation of the capacities of the various Administrative Units. After also fomparing the existing powers vested on the officers at corresponding levels in the Kerala Public Works Department and Central Public Works Department, the Commission has made of the recommendations:—

RECOMMENDATION No. 32:—Technical powers may be delegated to the various officers as suggested in Annexure XI of the report.

RECOMMENDATION No. 33:-Power to accept Tender excesses may be reduced to 5 per cent uniformly at all levels.

### Recommendation No. 34

Inorder to free the Superintending Engineer, from their desk work are to unable them to perform their inspecting and

supervisor functions effectively, the post of personal Assistant to the Superintending Engineers may be upgraded from Assistant Engineers to the Executive Engineers level,

### Recommendation No. 35.

The Assistant Engineer, should check 50 percent of all recorded measurements 75 percent of all hidden items and items of high unit value and his check measurement should over 75 percent of value of the work. The Executive Engineer, should check 10 percent of all measurements in respect of work valued at Rs. 50,000 and above. The items checked by him should cover the types which lend themselves easily to fraudulent practices. The Superintending Engineer should inspect in detail all works above of Rs. 3.00 lakhs and certify their confirmly to approved designs and estimate and freedom from noticeable defects,

The Government have carefully examined the recommendation of the commission in consultation with Heads of Department and other concerned and pass the following orders.
