Sub: Notification inviting Nominations for the posts of Central Office Bearers of "Association of Engineers TNPWD & TNWRD" & "Assistant Engineers' Association TNPWD & TNWRD", Chepauk, Chennai-5 for the year2024-26.

- 1. The General Body meeting of Association of Engineers, TNPWD & TNWRD and Assistant Engineers' Association, TNPWD & TNWRD which met at Trichy on 17.02.2024, have constituted the Chief Election Committee for conducting the Election of the Central Office Bearers of AOE, TNPWD & TNWRD and AEA, TNPWD & TNWRD election for the year 2024-2026. Accordingly the notification as hereunder is issued, calling for nominations as per Appendix-I of TNPWD & TNWRD Election Rules of Revised Byelaws of Association of Engineers TNPWD & TNWRD and Assistant Engineers' Association, TNPWD & TNWRD approved by the General Body on 14.10.1990 at Madurai, as per approved additions and amendments to the bye-laws made in the CEC held on 16.12.1995 at Dindigul, in the CEC held on 14.02.1998 at Thanjavur, in the CEC held on 29.01.2011 at Vellore and in the GB Meeting held on 17.02.2024 at Trichy.
- 2. As per the Election Rules and Regulations in force, the names and number of posts for which elections are to be conducted for the year 2024-2026 for "Association of Engineers TNPWD & TNWRD" and "Assistant Engineers' Association TNPWD & TNWRD" are furnished in Annexure-I and Annexure-II respectively of this Notification.
- 3. In conformity with the above Rules and Regulations, nominations are invited from the eligible members of the Association as on 02.05.2024 i.e. current Members of Association who have paid the annual subscription of **Rs.2000/-** for the year 2024 as on 02.05.2024 and Life Members who have paid the Special Subscription of **Rs.1000/-** for the year 2024 as on 02.05.2024 in the standard format (Copy enclosed in Annexure-III) and as per the election schedule specified in Annexure-IV. It is informed that the member wiling to contest in Election should have become member of AOE TNPWD & TNWRD and AEA, TNPWD & TNWRD within the cutoff date of 02.05.2024.
- 4. The following amendments as approved by the Combined C.E.C. held at Thanjavur on 14.02.1998, based on the CEC on 10.06.2017 at Chennai, based on the Central Executive Committee meeting held on 20.05.2023 at Thanjavur and GB Meeting held on 17.02.2024 at Trichy may please be noted while submitting the nominations to the Chief Election Committee.

Rule 1:	For the post of President and General Secretary of AOE and AEA member contestant shall be proposed by a minimum of 10 members and seconded by another 10 members who are to be spread over atleast in 4 District Branches and the member contestants should have served as an Office Bearer (including E.C. members) either in the Parent Association or in any of the Branches at least two years previously.
Rule 2:	All contesting members for every post in AOE and AEA shall be full-fledged members in the ENGIBEF Phase III / Phase IV / Phase IV Modified / V Phase and further shall be members continuously atleast for the immediate preceding two years.
Rule 3:	The Executive Committee Members (5 Nos) to the Association of Engineers and Executive Committee members (10 Nos) to the Assistant Engineers' Association shall be nominated by the newly elected Parent Executive Committee, at its first meeting after assumption of office (hence no election will be held for the Executive Committee Members posts both in Association of Engineers and Assistant Engineers' Association).
Rule 4:	For posts other than President, Vice President and General Secretary Rule 1 shall not apply, but other conditions stipulated in the Rule 2 above shall apply.
Rule 5:	For the eligibility of voters, all Current Members or Life Members who has paid annual (or) Spl. Subscription upto the day of election.

- 1. Nomination for contesting election from eligible members of AOE, TNPWD & TNWRD and AEA, TNPWD & TNWRD will be invited by a separate nomination invitation letter on 02.05.2024.
- 2. The nomination forms in plain paper duly filled in may please be sent to Er.N.Suresh Babu, Chief Election Convenor, Chief Election Committee, AOE, TNPWD & TNWRD and AEA, TNPWD & TNWRD, Chepauk, Chennai-600005 in a closed and sealed cover so as to reach him before 6.00 p.m. on 17.05.2024. Any nomination received after the stipulated date and time shall be rejected and the Chief Election Committee shall not be held responsible for the postal delay or loss in transit in this matter. No correspondence shall be entertained in this regard. To avoid such embarrassment, candidates are advised to send / hand over the nominations in person to the Chief Election Committee well in advance.
- 3. Nominations received will be scrutinized for their eligibility for the post to be contested based on the provisions of the byelaws and various amendments to the byelaws of AOE TNPWD & TNWRD and AEA TNPWD & TNWRD which are in vogue and the list of valid nominations will be communicated on **24.05.2024.** The last date and time for withdrawal of nominations will be **29.05.2024 upto 6.00 P.M**
- 4. All the valid nomination forms received by the Chief Election Committee within the stipulated time and date shall be opened at 6.30 p.m. on **29.05.2024** and listed in the presence of members present at Association Office premises, Chennai.
- 5. The list of final contestants will be finalized thereafter and sent to all Branches of AOE and AEA as well as to the contestants on **01.06.2024** by

- post / email and also will be displayed in the Parent Association Office Chennai.
- 6. We request your earnest cooperation in conducting the above election in a fair and free manner in accordance with the Election Rules (Appendix.I) of revised Bye Laws of AOE, TNPWD & TNWRD and AEA, TNPWD & TNWRD.
- 7. Details / clarifications, if any, sought for from the candidates on their nominations proposed have to be submitted by them within 24 hours to decide on the validity of their nominations. The nominations which do not comply with the eligibility requirements will be rejected. The decision of the Chief Election Committee is final in respect of matters pertaining to Election and no member can question its decision. It is for the kind information to all the members of the Association that the Chief Election Committee will function and act as per the provisions and various approved amendments of revised and updated Election Bye-laws of the Association.
