

MINUTES OF THE COMBINED 5th PEC MEETING OF AOE & AEA HELD ON 05.12.2024

The combined **5th Parent Executive Committee meeting** was held at Association Office at 6.15PM on 05.12.2024. **Er.H.Velan**, General Secretary, AEA welcomes the office bearers of PEC.

Er.S.Manikandan, President, AOE presided the meeting and called on the General Secretary, AOE to brief about the agenda.

Er.M.Dhanasekaran, General Secretary, AOE briefed about status of Pay case & clarification petition and also informed that the Government has filed an appeal petition against the Court Order dated 04.04.2024 and affidavit has been served to us. Most of the Treasuries are not responding to Court Order by relying the letter from Secretary (Expenditure), Finance Department, dated 05.01.2023 and communicating the same to DDO's vide their Letter (Eg. letter from Treasury Officer, Tenkasi No.RC No.1013678/2024/B1 dated 14.11.2024), so new case WP(MD)29215/2024 for the letter issued by Treasury at Tenkasi has been filed at High Court of Madras, Madurai Bench and expected the hearing on Friday 06.12.2024.

Er.S.Gopalakrishnan, Vice President, AOE suggested that since the appeal has been filed, which need to be defended by engaging renowned Senior Advocates.

The General Secretary, AOE has explained the panel status, for promotions of AE to AEE in WRD: Promotion orders will be issued shortly for the members included in promotion name list G.O. already issued and for promotion of AE to AEE in PWD: The G.O. for name panel list will be issued soon.

The General Secretary, AOE informed that the hearing of case connected with the promotion of AEE to EE has been adjourned on 17.12.2024. So, office bearers suggest to have meeting with petitioner based on the hearing to find possible solutions and way to achieve promotional panel.

Er.D.Sivakumar, Treasurer, AOE & AEA informed that, the work of preparing Diary & Calendar 2025 has been started, it is need to be finalise the office bearers name list and member list. So there shall be special request has to be made to finalise name list and diary at the earliest.

After having discussion, the Secretary (Publication) suggested to have New year get together function in office premises itself on 30.12.2024 evening.

Regarding the membership of office bearers for branches, the President, AOE suggested that all the branches shall be informed to finalise list of office bearers as usual by including representation from PWD and WRD. No of membership shall also be finalized in this fashion.

The General Secretary, AOE informed that the uploading of digitized Technical books, Poriyaalar books in website is in progress soon and will be published.

Er.M.Suganthi, Joint Secretary, Publication, AOE also suggested to include details of members in ENGIBEF Scheme in our website.

After having detailed discussion on the above agenda, the following resolutions passed unanimously:

1. Resolved to collect Legal fund, so as to engage renowned Senior Advocate in appeal of Pay Case based of necessity arise in future.
2. Resolved to request Engineer-in-Chief for early promotions & postings of AE to AEE.
3. Resolved to have meeting with petitioners of case filed in relation with bifurcation case based on the status of hearing on 17.12.2024.
4. Resolved to request all the branch office bearers to finalise branch office bearers list as usual as followed the previous year, and also to send membership list of both PWD & WRD to finalise no. of Diary & Calendar 2025 to print.
5. Resolved to get an explanation regarding formation of TNPWDEA from the office bearers of TNPWDEA about its necessity and functionality.

The meeting came to an end with the vote of thanks by **Er.S.Srinivasan**, President, AEA by about 8.00 P.M.
